## RELEASE AND INDEMNITY AGREEMENT

I state that I wish to participate in activities offered by the Boeing Employees Autosports Club, (hereinafter referred to as "Autosports Club") a Boeing Recreation Club. **I RECOGNIZE THAT ANY AUTOSPORTS CLUB ACTIVITY MAY INVOLVE CERTAIN RISKS AND DANGERS.** I certify that I am aware of all the obvious and inherent dangers of autosports, including but not limited to, inadequate safety equipment, improper training, miscalculations, inexperience, race track conditions or condition of any other surface intended for autosports activities, weather conditions, mechanical failure, accidents or illness in areas without medical facilities, and the actions of any other club members, any participants or any other persons all of which may result in personal injury, death, property damage and other losses.
